Personal information Consent: The Applicant(s) (collectively, “you” or “your”) consent to the collection, use and disclosure of personal information by Motion Financial Corporation. (“we”, “us” or “our”) as follows:

- We may collect and use personal information provided by you in your application for the purposes of verifying and evaluating your application, your identity (including for regulatory compliance purposes), your creditworthiness (including by obtaining and using credit reports), and other information provided to us in connection with your application. Social Insurance Numbers or other personal identifiers, if provided, may be used to verify your identity, including matching credit records.
